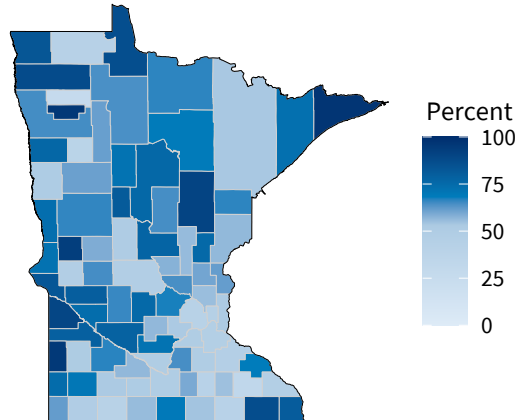

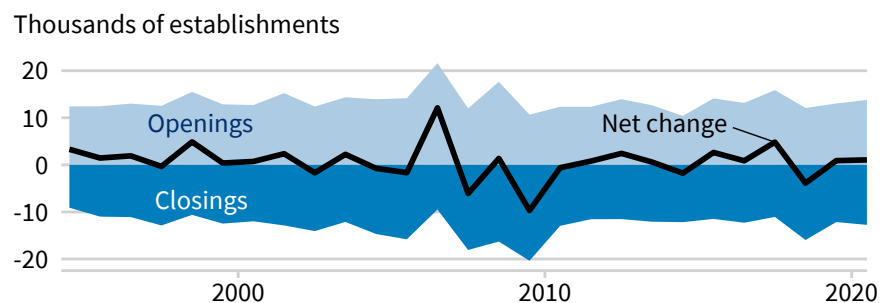
Share of employees working at small businesses by county

Business dynamics

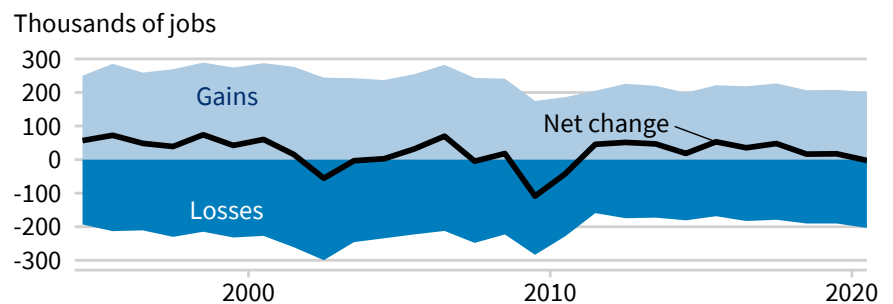
Establishments

Between March 2019 and March 2020, 13,797 Minnesota establishments opened and 12,740 closed, for a net increase of 1,057. Employment expanded at 33,929 and contracted at 34,413. Small businesses accounted for 13,527 openings and 12,535 closings.



Employment

Opening and expanding Minnesota establishments added 200,949 jobs, while closing and contracting establishments lost 203,498, for a net decrease of 2,549 jobs. Small businesses gained 164,798 jobs and lost 164,115, for a net increase of 683 jobs.

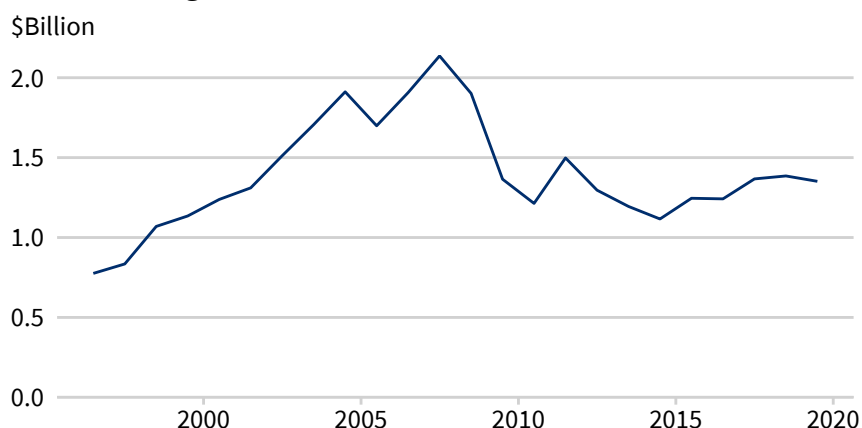

Small business loans

The Community Reinvestment Act requires large banks to report new small business loans. In 2019, reporting banks issued \$1.4 billion in loans to Minnesota businesses with revenues of \$1 million or less. Total reported new lending to businesses through loans of \$100,000 or less was \$1.6 billion, and total reported new lending to businesses through loans of \$1 million or less was \$4.0 billion.

Small business exports

A total of 8,469 identified firms exported goods worth \$20.7 billion from Minnesota in 2019. Of those exporters, 7,268—or 85.8 percent—were small. Small firms exported goods worth \$5.0 billion, making up 23.9 percent of exports by identified firms.

Women made up 47.9 percent of workers and owned 41.1 percent of businesses.

Veterans made up 4.1 percent of workers and owned 7.1 percent of businesses.

Racial minorities made up 13.9 percent of workers and owned 9.6 percent of businesses.

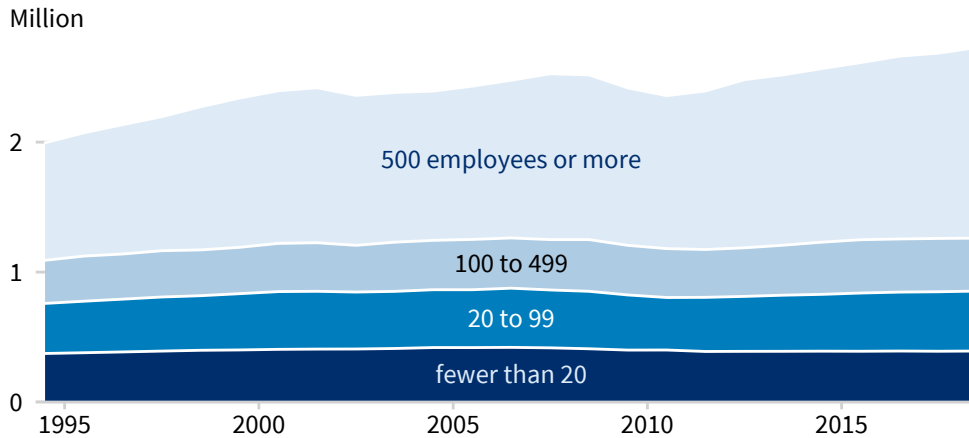
